Surcharges (Effective July 1, 2016)

The following surcharges are established for pollutant loads in excess of the criteria set forth in section 3.3 of the SUO (ie; @ concentration levels in excess of 300mg/l):

INSIDE

c _{CBOD}	= \$1,106.00 per 1,000 pounds of excess CBOD
c _{TSS}	= \$1,099.68 per 1,000 pounds of excess TSS

OUTSIDE

c _{CBOD}	= \$1,935.51 per 1,000 pounds of excess CBOD
c _{TSS}	= \$1,924.44 per 1,000 pounds of excess TSS

**Schedule of Penalties and Fines
Roanoke Rapids Sanitary District
Sewer Use Regulations/Enforcement Response Plan**

Fines (See ERP or Section 8.2 of the Sewer Use Regulations (SUO))

The following fines are established as a guide for violations of SUO Conditions or Permit Limits set forth in the user's pretreatment permit. It shall be noted that these fines may be higher or lower depending on the severity of a particular violation and shall be based on the criteria established in 8.2(b):

Regular Violation	=	\$150 per violation
TRC	=	\$250 per violation
Chronic	=	\$300 per violation
Both TRC & Chronic	=	\$500 per violation
Failure to Sample	=	\$100 per violation
Failure to Meet IUP Conditions	=	\$150 per violation
Failure to Meet SUO Conditions	=	\$100 per violation
Failure to Monitor, Submit Reports and Meet Milestone Dates – Enforcement Orders	=	\$200 per day, per violation
Failure to Clean Grease Trap, as Scheduled	=	\$300 per violation
Sewer Overflow Due to Grease Blockage (Excluding Cost To Clean-up)	=	\$250 per violation

As is set forth in the District's SUO, permit compliance assessments will be conducted every six months. At the end of a six-month review period, the District will determine whether the subject user is considered a chronic or TRC violator. If it is determined that the user is neither a chronic nor a TRC violator, the user will be assessed \$ 100.00 for each violation during the previous six months. If it is determined that the user is a TRC violator and not chronic, the user will be assessed \$ 200.00 for each TRC violation and \$100.00 for each regular violation. If it is determined that the user is a chronic violator, the user will be assessed \$300.00 per violation. In the event that a user is considered both in TRC and chronic categories, all violations will be assessed at \$ 500.00.
